ALTHOUGH 4,000 MEMBERS WERE ADDED TO CUPE'S RANKS AS A RESULT OF THE LAST WAVE OF UNION RAIDING, NEITHER CUPE NOR ANY OF THE OTHER UNIONS WAS IN FAVOUR OF THE RAIDS. IN FACT, ALL WERE UNITED IN CONDEMNING IT. MINISTER BARRETTE'S LAW ABOLISHING THE HEALTH AGENCIES AND FORCING MERGERS OF HEALTHCARE INSTITUTIONS HAS SIGNIFICANTLY DESTABILIZED THE HEALTH AND SOCIAL SERVICES NETWORK AND ERODED WORKING CONDITIONS. THIS HAS BEEN A TUMULTUOUS PERIOD FOR EVERYONE.

The time has now come to join forces and stand up to our common adversary, the Liberal government!

I would like to share with you something that happened in the Local Union where I serve. The situation I'm about to describe is pretty representative of what can happen in any institution in the healthcare network.

CUPE-4628 is now the new union for the class 3 administrative personnel of the CIUSSS du Centre-Sud-del'Île-de-Montréal. To ensure that all its members were well represented, the Local reached out to activists from other unions to ask them to continue working for the common cause.

We were lucky to be able to welcome newcomers from the CTC-FTQ, the CSD, the CSN and other organizations. Among them were former CSN activists Mélissa Morin and Céline Langevin, who were eager to talk about the experiences they had had during the transition period.

General Councils

7 et 8 novembre 2016

Social Affairs Coordinator Alain Tessier reported on our pension plan's rate of return, which was 5.57% for the third quarter of 2016, or 1.32% more than the threshold for sound management.

He also summed up the first meeting of the national labour relations committee in a few short words - many problems, few solutions.

CUPE communications representative Sébastien Goulet, along with representatives from the Organizing Department, launched the Healthy Choice campaign.

The CPAS Action Committee also made its report. Since the last General Council, the ambulance has made 17 trips, visiting the Beauce, Chaudière-Appalaches, Bas-St-Laurent, Quebec City and Abitibi-Témiscamingue regions.

Laurence C. Royer, CRDITED Chaudière-Appalaches, was elected to the Youth Committee. Gyslain Gaudet, Institut Philippe-Pinel de Montréal, and Véronique Bouchard, Institut universitaire de cardiologie et de pneumologie de Québec, were elected to the Information Committee.

Members of the Status of Women Committee provided training on the Simplified Guide to Parental Rights.





March 2-3, 2017

Social Affairs Coordinator Alain Tessier gave an account of two further meetings of the national labour relations committee. Reminding us of the various issues, he reported that no solutions had been found.

He discussed a decision regarding article 29 of our collective agreement, in which the arbitrator fined the employer \$1,000 for failing to file documents within the time period provided in the collective agreement.

The CPAS Action Committee reported that the ambulance went out 43 times, covering a distance of 12,700 km across Québec.

CPAS Secretary General Michel Jolin presented the financial reports for the past year, showing that the CPAS is in good financial shape.

May 15, 2017

Alain Tessier presented the results of the triennial actuarial audit, which were recently made public. As at December 31, 2014, 540,657 active members had paid their dues. The average salary was \$53,450 and the average age 42. There were 231,391 retirees, i.e. 48,000 more than in 2011. With a funding status of 103.7%, our plan is in excellent health.

Alain announced the launch of a comparison study of collective agreements with the Comité patronal de négociation du secteur de la santé et des services sociaux (CPNSSS). This process is designed to ensure that members of other union organizations do not lose any of their rights when changing to a different collective agreement.

Yanick Ducharme, Institut Philippe-Pinel de Montréal, Frédéric Brisson, Institut universitaire de cardiologie et de pneumologie de Québec, and Jonathan Deschamps, Montréal West Island IUHSSC, were elected to prepare the upcoming study session on the collective and local agreements.

Mélanie Gougeon, union representative with the SCFP's Evaluation department, reported on progress on 2010 and 2015 maintenance with the Conseil du trésor. We learned that the FSSS-CSN has withdrawn from the conciliation process for 2010 maintenance, and we are now waiting for the Conseil du trésor's response.

Recent development:

The Conseil du trésor has notified the unions that the government will not be presenting its settlement offer due to the FSSS-CSN's withdrawal from the conciliation table.

We have therefore referred the complaints concerning SCFP-Québec's 2010 pay equity maintenance to the CNESST's investigation department.

Our goal is to trigger a settlement for our members who have been waiting for a very long time. The SCFP pay equity committee has already started its investigations. Further updates will be provided as the work progresses.

Special convention

May 31 and June 1, 2017

A special convention was held to review the Constitution of the Conseil provincial des affaires sociales. Further to the union raiding campaigns, we need to revisit our operating methods. Seven amendments were necessary, affecting the following articles:

- Article 5: Représentation au Conseil général
- Article 6: Redéfinition des vice-présidences régionales
- Article 6: Création de vice-présidences par catégorie

But in the end, it survived the cold and chugged back to life, staying in one piece except for a few lost hubcaps and a lack of serious housekeeping. Let's not forget it was home to two men. In another incident, our heroes forgot to turn off their ambulance lights on the Metropolitan. It was only a few kilometres later that they realized why Montreal drivers were being so courteous and letting them through. That was a pretty good Friday. Such great memories and so many more!!!

Frédéric summed up his extraordinary experience as follows: *"It was the trip of a lifetime. Three intense months on the road with my "brother Pierre." Wow! We sure know Québec now! We have friends, brothers and sisters everywhere.... We're one big family!"*
